TEAM SKATING TESTS (TST)

Aufgrund der gemachten Erfahrungen der letzten Jahre werden die Reglemente der SyS-Teste wie folgt angepasst :

Auszüge aus ISU Team Skating Test Program, Judges Handbook 1997:

FIFTH CLASS – WHITE (TST JH 1997, Seite 13)

6. Forward pivot wheel. Pivot wheel must rotate a minimum of two (2) rotations with a maximum of four (4) rotations. Minimum number of skaters per pivot line is eight (8) and the maximum numbers of skaters per pivot line is fifteen (15). Each pivot line must skate individually. **Maximum of two (2) pivot wheels** . Shoulder hold.
7. Backward two-spoke pinwheel with simple chasse steps **or crossovers**. At least two (2) rotations with a maximum of four (4) rotations. Shoulder hold. **Maximum of two (2) Backward two-spoke pinwheels if there are more than sixteen (16) skaters. Each Backward two-spoke pinwheel must skate individually.**
8. Forward "V" intersection. Maximum of two (2) intersections are permitted. One half of the team must intersect with the other half of the team. Shoulder hold.
9. **Replace: Forward or Backward Line intersection (see JHB 1999, page 48). Minimum of three (3) lines, maximum of four (4) lines. At least two (2) intersections with a maximum of four (4) intersections. The distance between lines during the intersection may be no greater than 2 metres (approx. 5-6 feet) apart. Shoulder hold.**

Bemerkung:

Die Art der Ausführung ist dem Team überlassen. Beispiele dafür werden am Preisrichterkurs vom 26.11.00 gegeben. 2/3 der Linien sollten während den Durchkreuzungen parallel und gerade sein.

FOURTH CLASS – RED (TST JH 1997, Seite 27)

1. Forward to backward circle incorporating crossovers or chassés in a clockwise or counterclockwise direction. Four revolutions: **totally two (2) forward and two (2) backward, number of changes of direction and kind of turns are optional.** Hand or shoulder hold permitted.
2. Backward line with eight (8) count step sequence (**four count step sequence, repeated on opposite feet is permitted**) to be repeated at least once **Delete** : *twice*. Line must stretch across the short axis. Free skating moves are not permitted. Shoulder hold.
3. Forward single line splitting into two (2) lines and back to one (1) line, **each part should cover approx. one third of the ice surface. Delete** : *The line must move for at least one count of eight (8) before splitting into two (2) lines. The two lines must then move for at least one count of eight (8) before moving back to one (1) line and continuing to move forward for a minimum of eight (8) counts.* Distance between the lines may be no greater than 1.5 metres (approx. 4-5 feet). **Delete** *Front or back catch hold.* **New: Hold(s) optional.**
8. Forward block intersection. Only one intersection is required. One half of the team must intersect through the other half of the team (**two (2) lines with two (2) lines**). **Delete**: *If 12-17 skaters, two (2) lines must intersect with two (2) lines; if 18-24 skaters, three (3) lines must intersect with three (3) lines.* At the intersection, skaters drop their hold and do a one or two-foot glide for two counts through the intersection. Then resume hold. Hand or shoulder hold permitted.

PART TWO: PROGRAM TO MUSIC

- Minimum of twelve (12) skaters. Maximum of **twenty (20)** skaters.
- **Well balanced program Delete**: *Minimum of four (4) different elements from the FIFTH CLASS (WHITE) and/or the FOURTH CLASS (RED) level tests.*
