The host will cover full board expenses for all judges from dinner on December 5 until dinner on December 7, 2003. All other expenses shall be the responsibility of each official or the entering association or club. The judges meeting will be held on Saturday morning, December 6, 2003.

Responsibility

In accordance to I.S.U. Regulation, Rule 119, all participants act on their own responsibility. The host will provide medical emergency aid during competition.

Technical Conditions

The competition is generally conducted in accordance with I.S.U. General Regulations 2002, Special Regulations Ice Dancing 2002 and relevant I.S.U. Communications. For age requirements in particular, Technical Regulation of Swiss Skating Union applies.

Novice Compulsory Dance: Rocker Foxtrot / Free Dance

Age Requirements:

Both girl and boy must not have reached the age of seventeen (17) by July 1st preceding the event and neither partner may be younger than ten (10)

Compulsory Dance 0.5 (33.3 %) Free Dance 1.0 (66.7 %)

Junior Original Dance / Free Dance

Technical Requirements:

Original Dance and Free Dance requirements according to I.S.U. Communication 1209 and following clarifications

Age Requirements:

Both girl and boy must not have reached the age of twenty-two (22) by July 1st preceding the event and neither partner may be younger than ten (10)

Multiplying Factors for Determination of Results:

Original Dance 0.6 (37.5 %) Free Dance 1.0 (62.5 %)

Senior Original Dance / Free Dance

Technical Requirements:

Original Dance and Free Dance requirements according to I.S.U. Communication 1209 and following clarifications

Age Requirements:

None

Multiplying Factors for Determination of Results:

Original Dance 0.6 (37.5 %) Free Dance 1.0 (62.5 %)

Calculation of Results

Results will be calculated in accordance to I.S.U. Regulation 1998, OBO-System.

Awards

The first three best-placed couples in each category of this event will be awarded with a trophy; all participants will receive special presents.

Accommodation and Expenses for Participants

All costs for travel, accommodation, meals for competitors, coaches, team leaders and chaperon shall be the responsibility of the participants or the entering association or club.

Initial Draw

The initial draw will be on Saturday December 06, 2003.

Schedule

There will be at least one official practice for the Compulsory Dance/Original Dance and one for Free Dance. First official practice will be on Friday afternoon. Provisional Schedule will be announced by November 10, 2003 to all entered clubs after the conclusion of entries.
